Ratification of appointment of Auditors is being sought in the ensuing Annual General Meeting. As required under the provision of Section 139 of the Companies Act, 2013, the Company has obtained written confirmation from M/s. C. K. Chandak & Co. that their ratification, if made, would be in conformity with the Companies Act, 2013.

REPORT ON THE FINANCIAL STATEMENTS

We have audited the accompanying financial statements of **LITTLESTAR TRACOM LIMITED (the Company)**, which comprise the Balance Sheet as at March 31, 2017, the Statement of Profit and Loss and the Cash Flow Statement for the year then ended, and a summary of the significant accounting policies and other explanatory information.

MANAGEMENT'S RESPONSIBILITY FOR THE FINANCIAL STATEMENTS


